Modern Slavery Statement

Introduction

LS Productions has a zero tolerance approach to any form of modern slavery. We are committed to acting ethically and with integrity and transparency in all business dealings and to putting in place effective systems and controls to safeguard against any form of modern slavery taking place within the business or our supply chain.

For the purposes of this policy, modern slavery encompasses slavery, servitude, human trafficking and forced labour, and is pursuant to section 54 of The Modern Slavery Act 2015, and this constitutes LS Production's statement on modern slavery. This statement relates to actions and activities during the financial year 2024/2025.

Our Business

LS Productions is a production partner providing expert knowledge on commercials, film and TV, music videos, fashion and sports campaigns. The company is based in the UK with offices in Edinburgh, Manchester and London and operates globally. We recognise the importance of taking responsibility for ensuring a robust approach to slavery and human trafficking. We also understand that modern slavery and human trafficking are significant global issues presenting a challenge for businesses worldwide, and we are absolutely committed to preventing slavery and human trafficking in our corporate activities, and to ensuring that its supply chains are free from slavery and human trafficking.

Supply Chain

Our supply chain covers many suppliers within the UK and globally. Our suppliers are engaged with on a project-by-project basis. We expect all suppliers and contractors to uphold the same values as us in our zero tolerance approach to any form of modern slavery. We will refuse to deal with any supplier engaged in slavery or human trafficking or knowingly permit them to be carried out in any part of their business.
